# ACE Update: Differences in Data Requirements for 06 Entry in ACE

# **Important Dates:**

- 2/28/16—Mandatory filing of all electronic entries and entry summaries in ACE including 06 Entries (ACS will be decommissioned for entry/entry filing)
- July/16—e214 transitioned from ACS to ACE
- Sept/15—CATAIR for entry (cargo release) in ACE published by CBP
- Oct/15—CATAIR for entry summary in ACE published by CBP

### What are the major differences?

The following data elements will be required for all 06 entries (individual and weekly):

#### Cargo Release (Entry)

- "W" flag and date for weekly entry, start of the shipping week (SE11 page SE28)
  - Will systematically make the "elected entry date" the first day of the zone shipping week
  - Applicable to weekly 06 entries only (not individual 06 entries)
- Location of Goods FIRMS code (SE11 page SE28)
  - For multi-site subzones operated under one FTZ operator's bond and one inventory control and recordkeeping system, one main FIRMS code will be allowed to be reported
  - Also, FTZ Zone ID reported in place of "conveyance name"
- Reason Code for correction or cancellation (SE13 page SE31)
  - o Entry replaced by admission (04)
  - No foreign-status merchandise shipped during zone shipping week (12)
  - Other opportunities for corrections?
- Zone status code N (for NPF) or code P (for PF) (SE41 page SE49)
  - Currently CBP FTZ Manual directs filers to include zone status in Field 22 (AWB/BOL/IT field)
  - o ACS CATAIR does not reference zone status as required data element
- Privileged date for code P (SE41 page SE49)
  - Only for PF status merchandise reported on the entry whose HTS classification at the time of election of PF status is no longer active (expired, superseded, no longer exists)
- FTZ Line item quantity (SE41 page SE49)
  - Possibly based on zone UOM, not on HTS UOM?
- FTZ Line item value (SE 60 page SE56)
  - Indicated as an optional field?
- Current HTS number for PF status merchandise along with original HTS that is no longer active (SE61 page SE57)
  - For PGA selectivity

- Country of origin and manufacturer
  - What COOs and MIDs are you currently including on your estimated 3461? All combinations per HTS? Only some combinations? With or without permission from CBP?
  - ACE will provide automated, systematic way for CBP to compare cargo release submission (quantities, values, COOs, MIDs) to entry summary submission
  - o Manufacturer name and address will replace MID code

#### **Entry Summary**

- SE41 FTZ line item quantity
  - Quantity of units removed from the FTZ; this is in addition to the HTS reporting quantity.
- SE 61 Current HS number for expired P status merchandise reported on a 7501
